

DCUO Xbox One Sweepstakes – Daily Trivia Sweepstakes

Official Rules

NO FEE OR PURCHASE NECESSARY TO ENTER OR WIN. THIS PROMOTION IS SUBJECT TO ALL APPLICABLE LAWS. VOID WHERE PROHIBITED.

Participation constitutes entrant's full and unconditional agreement to and acceptance of these Official Rules for the applicable sweepstakes (the "Sweepstakes"). Please see the specific Sweepstakes below for the Sweepstakes dates, times, and other details. Each Sweepstakes is sponsored by Daybreak Game Company LLC, 15051 Avenue of Science, San Diego, CA 92128 ("Sponsor"). Submissions are administered by Votigo, Inc. ("Votigo").

Sweepstakes are in no way sponsored, endorsed or administered by, or associated with Facebook, Instagram, or Twitter. Any information that you provide is being collected by Votigo and will not be provided to the social media site. Votigo may provide your information to Sponsor for winner selection and prize fulfillment purposes, and if you opt-in to receive Daybreak news and updates, for marketing purposes.

Daily Sweepstakes:

Answer a quick trivia question (you do not have to get it right) in order to enter a Sweepstakes on each of the following days:

- Day #1 = Friday, April 29, 9:00AM PDT – Saturday, April 30, 9:00AM PDT
- Day #2 = Saturday, April 30, 9:00AM PDT – Sunday, May 1, 9:00AM PDT
- Day #3 = Sunday, May 1, 9:00AM PDT – Monday, May 2, 9:00AM PDT
- Day #4 = Monday, May 2, 9:00AM PDT – Tuesday, May 3, 9:00AM PDT
- Day #5 = Tuesday, May 3, 9:00AM PDT – Wednesday, May 4, 9:00AM PDT

Grand Prize Sweepstakes:

If you are a US legal resident (as described below with additional eligibility restrictions), by entering into a Daily Sweepstakes above, you will automatically be entered into the Grand Prize Sweepstakes. Therefore the Sweepstakes period for the Grand Prize Sweepstakes is:

- Friday, April 29, 9:00AM PDT – Wednesday, May 4, 9:00AM PDT

Eligibility: Each Daily Sweepstakes is open to everyone eighteen (18) and over at the time of entry, except employees (including their immediate family members and persons living in the same household), officers, directors, and agents of Sponsor, Votigo, Facebook, Twitter, and Instagram and their respective parent companies, affiliates, subsidiaries, advertising, promotion, and fulfillment agencies, who are not eligible to participate in the Sweepstakes. The Grand Prize Sweepstakes is open to those eligible for the Daily Sweepstakes above, but participants also must be a **legal resident of the 50 United States or the District of Columbia**. How to Enter: To enter and participate in one of the Daily Sweepstakes, answer the trivia question presented in Votigo (you do not have to get the answer right) – one entry per person. A participant may also receive up to five (5) additional entries by sharing the provided referral link **and** the referred person also enters the Sweepstakes.

To enter and participate in the Grand Prize Sweepstakes, you must participate in one of the Daily Sweepstakes. Each valid and eligible entry in the Daily Sweepstakes will count as an entry in the Grand Prize Sweepstakes (so the maximum number of entries per participant is thirty).

Determination of Winners: Sponsor will randomly determine three (3) winners for each Daily Sweepstakes and two (2) winners for the Grand Prize Sweepstakes. Winners will be randomly selected by Sponsor from eligible entries submitted during the relevant Sweepstakes period. **To be considered, you must submit your entries to Sponsor as set forth herein no later than the time and date set forth in the specific Sweepstakes.** Sweepstakes are limited to one (1) entry per person except as otherwise noted above. Duplicate entries (more than one (1) entry per participant or five (5) referral entries), any entries submitted by agencies, other third parties, or through other unapproved methods are void. Any attempt at entry except as stated herein is void. Sponsor will not provide you with confirmation of receipt of your entry.

By participating in any Sweepstakes, you agree to comply with the rules set forth in the Sweepstakes and these Official Rules. Participants who do not comply with these requirements will be disqualified.

Daily Sweepstakes: For each Daily Sweepstakes the prizes are: (i) First Place - one (1) DCUO Ultimate Edition for the Xbox One (ARV US\$65.00), (ii) Second Place - one (1) DCUO Power Bundle for the Xbox One (ARV US\$30.00), and (iii) Third Place - 2,000 Marketplace Cash for the Xbox One (ARV US\$20.00), to be distributed to one (1) randomly selected winner for each placement during the Sweepstakes period specified in the relevant Daily Sweepstakes.

Grand Prize Sweepstakes: The Grand Prize Sweepstakes prize is: Xbox One and a DCUO Ultimate Edition bundle for the Xbox One 500Gb Console Bundle (Gears of War ultimate edition, Forza Motorsports 6, Rise of Tomb Raider (ARV US\$415.00), to be distributed to each of the two (2) randomly selected eligible Grand Prize winners.

Determination of Winners and Prizes: Winners will be selected randomly from eligible entries. Odds of winning depend on the number of entries received. Votigo will use the information that you provide in accordance with its Privacy Policy, and Sponsor will use the information that you provide in accordance with its Privacy Policy. You agree that Daybreak shall remain the exclusive owner of all game content and intellectual property rights in its games, including all such content that may appear in your screenshot entry and by submitting the screenshot, you agree that Daybreak has the right to use the submitted screenshot for any and all purposes, including marketing, advertising, and promotional purposes in any and all media now known or hereafter devised. All disputes, controversies or differences which may arise between the parties out of or in relation to or in connection with this Sweepstakes shall be finally settled through arbitration administered by JAMS or the American Arbitration Association (AAA) in accordance with the AAA's Commercial Arbitration Rules.
